Instructions for street vendor's permit

- 1. Must bring an original surety bond to <u>ARA</u> at 1002 Washington, 1st Floor, in the sum of \$10,000.00 (Ten-Thousand Dollars) with the MINIMUM term of Two (2) years and seven (7) days.
- 2. Permit Fee: current Street Vendor Permit and Administrative fees; permit is valid for seven (7) days.
- 3. Bring a photo ID or driver's license card or an ID issued by a government agency.

NOTE: In general, the fee for this bond is not \$10,000.00 (Ten-Thousand Dollars); however, the insurance or bond agency may charge you up to 10% of the ten thousand dollar value of the bond, (or less than \$1,000.00). You may request the surety bond from an insurance agency or bond agency of your choice.

Insturcciones Para Permiso De Vendedor en Calle:

- 1. Debe traer un bono de seguridad original a <u>ARA</u> 1002 Washington, en el Primer piso con el bono de seguridad valorado \$10,000 (diez-mil-dolares) con el termino minimo de dos (2) años Y sieta (7) dias. El nombre del bono es "Street Vendors Bond" (bono de vendedor ambulante) o "Surety Bond" (Bono de seguridad).
- 2. Permiso de vendedor ambulante actual y tarifa administrativa. Este permiso es valido por 7 (sieta) dias.
- 3. Traer una identificación con foto, licencia de manejar, o una identificacaión de alguna agencia de gobierno.

NOTA: En general, el costo de este bono de seguridad no es \$10,000.00 (diez-mil-dolares). Las agencias pueden cobrar hasta el 10% de los \$10,000. (o menos de \$1,000.00 dolares). Tiene que solicitor el bono de seguridad en una agencia de aseguranzas o agencia de bonos (bail bonds) de su eleccion.
