CERTIFICATE OF OCCUPANCY



Prior to occupancy of the building, or the establishment of utilities, all fees and final Inspections shall be approved.

A certificate of occupancy can be requested by calling 832-394-8847.

Once the certificate is requested, it will be printed and the owner or agent can pick up the certificate in person. The certificate must be posted on the premises as per the Building Code.

OVERVIEW

AUTHORITY



The City of Houston regulates building construction and occupancy to ensure the safety and welfare of occupants. The construction codes are adopted by ordinance and regulated by the Building Code Enforcement Branch in the

Houston Permitting Center Service Line of Houston Public Works .

GENERAL CODE INFORMATION

The Building Code provides a classification designation for each occupancy and use. The occupancies that are separated out by groups as Assembly, Business, Educational, Factory, High Hazard, Institutional, Mercantile, Residential, Storage, Utility and Miscellaneous.



Construction requirements are also defined and vary by the type of materials used for construction and the size of the structures.

The Code designates the following basic processes for the construction and use of the building.

- Application
- 2. Plan Review
- 3. Inspections
- 4. Utility Release/Certificate of Occupancy

APPLICATION & PLAN REVIEW PROCESS

To apply for a permit, an applicant would need to submit the following package to the Building Code Enforcement Permit Office at the Houston Permitting Center located 1002 Washington Avenue or any of our three satellite offices.

MINIMUM SUBMITTAL PACKAGE

- <u>Building Permit Application</u> (CE-1263)
- <u>Declaration in Support of Application for City of</u> Houston Building Permit
- Commercial Prerequisite Checklist, supporting documentation and plans (CE-1105)
- Storm Letters of Availability
- 2 sets of complete plans for the scope of work
- New Construction must have address(es) verified by the Building Code Enforcement Permit Office before the application is submitted.

NOTE: Separate processes, such as Planning, may be required before submitting plans.

Internally, plans will be routed and reviewed by the various review sections as applicable.

Once the plans are approved and the fees are assessed, the building permit may be purchased by the owner or other authorized person. Subsequently, trade permits will need to be purchased, in most

cases, by a registered licensed individual.

INSPECTION PROCESS

After all permits are purchased, inspections may be scheduled.

The following inspections are typical for most projects.

STRUCTURAL

 Foundation inspection -To ensure the structural integrity of the foundation.



- Wind storm inspection -To verify the use of wind straps.
- Frame inspection To ensure the structural integrity of the frame.
- ♦ Energy inspection Windows, insulation
- Final inspection To ensure full compliance with the building code

MECHANICAL, ELECTRICAL & PLUMBING

- Ditch or slab cover inspection
- ♦ Wall cover inspection
- Ceiling cover inspection
- Temporary cut-in inspection
