IDM Variance

- The IDM shall be followed.
- In the instances when an applicant believes that the design criteria as stated in the IDM cannot be followed an IDM variance can be submitted for review.
- Each submittal will be evaluated by OCE's engineering staff on a case by case basis.
- Each variance request will be approved or denied.
- Submittal of an IDM variance **does not** in any way guarantee an approval of the variance.
- All engineering support documentation and applicable <u>legible</u> drawings shall be submitted with the application. Provide pictures of the right-of-way (ROW) area conditions if applicable.
- All incomplete variance request forms or requests that do not provide sufficient technical support documentation will be rejected.

- Allow 4 weeks for the review of an IDM variance.
