Non-Consent Tow Truck Driver I understand the removal of vehicle without the consent of the vehicle owner from private property falls under Chapter 2308 of the Occupations Code. Initials I will be in compliance with the City of Houston non-consent towing ordinance as specified under Chapter 8, Division 2, Subdivision B, Wrecker Driver Licenses. Initials I understand I may not charge more than the City of Houston non-consent tow rate as authorized under Chapter 8-123. I understand if the vehicle owner is present or comes upon the scene where an auto wrecker is attempting to tow a vehicle, and the vehicle owner does not desire the vehicle to be towed, no charge shall be made and the Initials vehicle owner shall be allowed to take possession of the vehicle if the vehicle has not been hooked up by the wrecker. If the motor vehicle has been lawfully hooked up to the wrecker, but not towed from the scene, the vehicle shall be released to the vehicle owner upon payment of one-half the regular wrecker fee. Initials I may not operate and charge fees for a heavy-duty wrecker unless I meet the heavy duty truck requirements as specified by City of Houston ordinance, Chapter 8, Definitions: Heavy-duty wrecker shall mean an auto wrecker having chassis rated at five tons or greater by the vehicle manufacturer and a winch capable of lifting a minimum of 30,000 pounds as rated by the winch manufacturer. Except where a distinction is made, the term "auto wrecker" includes a "heavy-duty wrecker." The auto wrecker must be registered with the Texas Department of Motor Vehicles as a tow truck. The tow truck will not tow any vehicle that exceeds the gross towing capacity as listed in the tow truck registration Initials files. Date Signature Police-Authorized Tow Service Agreement Tow Truck Driver Unless specifically authorized by a law enforcement officer, I will not service a major freeway without a Major Freeway Tow Service Agreement authorization and identification card issued by the Houston Police Department Auto Dealers Detail. It is prohibited for a wrecker company tow slip to contain any language that authorizes additional services that may be applied to a vehicle towed from a police scene. Specifically, no statement that additional Initials towing, storage, or repairs for service in addition to the tow service provided at the police scene may be indicated. No amended consent ticket or additional service agreement may be presented to the vehicle owner/operator of a vehicle removed from a police scene that attempts to circumvent any provisions of the PATSA or City of Houston Ordinance. Complaints regarding the officer's selection will not be argued at the scene. No delay or disruption of the scene investigation will be tolerated. Complaints may only be made after the scene has cleared. Tow company Initials complaints may be directed to the investigating officer, the officer's supervisors, or to the Auto Dealers Detail. The officer's decision will be subject to review by appropriate authority. Any notice or directive distributed to Operators of Police Authorized Tow Service Agreements by the Houston Police Department regarding towing from police scenes will be followed unless rescinded by the Initials

Houston Police Department. I have initialed each paragraph acknowledging these directives. I understand that if I fail to comply with these wrecker driver's requirements, a hearing will be held to revoke my City of Houston Wrecker Driver's License. Initials I acknowledge that the wrecker license is the property of the City of Houston and must be surrendered upon demand by an officer with the HPD Auto Dealers Detail.
