The undersigned bind themselves to defend at their own cost and expenses any suit or suits, action or actions, claim or claims or damages which may be sustained against the City of Houston for any loss, cost, expense, or damage charged or imposed upon it by reason of granting said permit and further agree to keep in good repair the refilling and surfacing necessitated by the excavation covered by this application for a period of one year.

It is also understood and agreed that this permit shall be granted subjected to the right of the City of Houston, or of any other person, entitled thereto to use that part of such public street, alley, or other public place for any purpose for which said street, alley, or other public place may be lawfully used, and the granting of any permit for the purpose of locating or placing any pipe, conduit, duct, tunnel, or other structure shall not be construed to grant to such person any fixed or vested right in such location, but all of same shall be taken subject to the right of the City or any other person entitled thereto to lay or place its pipes, conduits or other structures in or under such portion thereof over, under or across such pipes, conduits, ducts or other structures as may have been laid without cost or charge being exacted by the prior location for such use.

In consideration of the granting by the City of a permit for constructing the above described storm sewers and/or related appurtenances and the use of the public properties of the City for such purpose, it is agreed that these sewers, when constructed to the City requirements, will be public sewers, the property of the City of Houston, and without right of reimbursement by the City for any of the costs thereof.

Conveyance of any Public [Non-"Utility District"-Type] Storm Sewer(s) and/or System(s) (But NOT Primarily Private Storm Sewer(s) and/or Storm Connections (Leads)), being located within any existing Public Road Right-of-way(s) and/or Storm Sewer Easement(s) Only, to the City is automatic upon City acceptance of any such City Inspected Public Storm Sewer(s)/System(s) built as per drawings having both a Houston Public Works Drawing No. and a currently valid engineering (& private utility companies, inside the City) approvals on the same.
